

Privacy statement Allinq Group BV

This is the privacy statement of the Allinq Group BV (located in Harderwijk, Fahrenheitstraat 27, 3846 BM, The Netherlands), its subsidiaries, and affiliated companies, hereinafter jointly referred to as Allinq. In this statement, we explain, among other things, why we collect and use personal data, what data this is, and what rights you have when we process your personal data.

In addition to this external privacy statement, we have drawn up a privacy statement for our (former) employees, trainees, and applicants.

Who are we?

Allinq is a specialist in Telecom infrastructure. We are active internationally and also have branches in Germany, the Czech Republic, and Denmark. Allinq provides the complete process for the construction of complex Telecom infrastructure.

Cookies

If you visit our website, we only use technical cookies to make the website function properly. We therefore do not use cookies where we process your personal data and for which we need your permission.

Why do we process personal data?

Among other things, we process personal data if this is necessary when carrying out our projects. This may involve making a house connection at the request of a provider or, for example, installing a communication network for a network operator. But also for answering your questions, for order confirmations, or sending or paying an invoice. We also use personal data to send our newsletter or customer magazine.

If you enter our premises as a visitor, it is possible that security footage is made. Camera surveillance takes place for the security of our properties, to provide evidence, and for quality purposes.

What data do we collect and use?

We collect contact details such as name, address, telephone number, and e-mail address. We also store when and about what we have been in touch with you. For example, when we make an appointment with you or process project orders that we carry out on behalf of our customers.

We also process personal data of employees of subcontractors or suppliers who perform work for Allinq at our clients projects.

May we process your personal data?

As Allinq, we are only allowed to use personal data for a reason stated in the privacy legislation. Such a reason is called a principle. The possible principles can be found in Article 6 of the General Data Protection Regulation (GDPR).

The two main legal principles on which we process personal data are because this is necessary for the performance of an agreement (Article 6(1)(b) of the GDPR) and to represent a legitimate interest (Article 6(1)(f) of the GDPR).

Other legal principles on which we process personal data are the consent of the data subject (Article 6(1)(a) of the GDPR) and compliance with a legal obligation (Article 6(1)(c) of the GDPR).

Permission

Do we process your personal data based on your permission? Then you can withdraw your permission at any time. From that moment on, we no longer process your personal data. Unless there (also) is another principle for processing your data.

Special data

In incidental cases, it is possible that we process special or sensitive personal data, such as a citizen service number, in which case we are only allowed to do so if there is a legal obligation to do so.

How do we secure your data?

We take both technical and organisational measures to secure the personal data that we process. For instance, so that this data does not go missing. We do this in accordance with the applicable legal requirements and guidelines.

An example of a technical measure is that we use two-factor authentication. This means that in addition to using a login name and password, a second verification of the user's identity takes place.

An example of an organisational measure is that only authorised employees are allowed to view your data. And these employees only have access to your personal data to the extent necessary to perform their duties.

How long do we store your data?

We do not store your personal data for longer than is necessary for the purpose for which we process your data. However, sometimes we are obliged to keep your data longer. An example of this is that we have to keep invoices for seven years under tax law.

Do we share your data with third parties?

In order to carry out our work, it may be necessary to share data with other parties (third parties). This can be within the Netherlands as well as within the European Union (EU). For example, we share customer contact details with subcontractors who, on our behalf, make a house connection with that customer in question.

When sharing your data, we strive to share as little data as possible.

What are your rights?

You have a number of privacy rights. For example, you can ask us which personal data we process about you. And if the data is not correct, you can have it corrected. In some cases, you can also ask us to delete, transfer or restrict the processing of your data.

Finally, you can object to the processing of your data. And do you disagree with how we process your data?
